**Description:**

The City of Holts Summit is accepting sealed bids for two 2016 Dodge Charger AWD. Both vehicles were used by the Holts Summit Police Department as patrol vehicles and were assigned as “take-home” vehicles. All police equipment has been removed; with the exception of the exterior spotlight. A minimum of at least one key (fob) for each vehicle will be provided at the time of sale.

Vehicle 1: 2016 Dodge Charger AWD with approximately 65,422 miles – VIN 2C3CDXKT4GH273129

Vehicle 2: 2016 Dodge Charger AWD with approximately 75,098 miles – VIN 2C3CDXKT8GH197530

- In the event of an equal bid, the first bid received will be awarded the vehicle
