A Delinquent Notice fee of 25% of the total license fee will be added to any application received after the deadline of June 1st.

Qualification of Applicants:

Pursuant to City of Holts Summit Code of Ordinances Chapter 6 Section 25.

No person shall be granted a license hereunder unless such person is of good moral character and a qualified legal voter and a taxpaying citizen of the county, town, city or village, nor shall any corporation be granted a license hereunder unless the managing officer of such corporation is of good moral character and a qualified legal voter and taxpaying citizen of the county, town, city or village.

No person shall be granted a license or permit hereunder whose license as such dealer has been revoked, or who has been convicted, since the ratification of the 21st Amendment to the United States Constitution, of a violation of the provisions of any law applicable to the manufacture or sale of intoxicating liquor, or who employs in his business as such dealer, any person whose license has been revoked or who has been convicted of violating such law since the date, provided that nothing in this section contained shall prevent the issuance of licenses to nonresidents of this state or foreign corporations for the privilege of selling to duly licensed wholesalers and soliciting orders for the sale of intoxicating liquors to, by or through a duly licensed wholesaler within this state.

Pursuant to City of Holts Summit Code of Ordinances Chapter 6 Section 23.

The annual license fees for licenses issued under this chapter shall be as provided in the table below. The license fee shall be submitted with the application for license, and no license shall be issued until the license fee is indicated as paid. Nothing in this chapter pertaining to fees may be construed to authorize the type of business for which a particular fee is determined.
